We Have Gas Generator & Diesel Generator which ensures for Frequent Power supply.

Salary and wages are paid to the workers as per gazette notification of the government of Bangladesh. Payment of salary and wages are made regularly within 07 (seven) working days of the following month after completion the work period.

## PROFILE OF TRIPLE I KNITWEARS LTD.

- **Over Time:** A. Overtime is calculated on the basic of double the basic salary, calculated of over time per hour is **Basic Salary \* 2 26(days)\*8 (hours)** Payment of overtime is made with monthly salary **7 (seven)** working days of each month.
- **Bonus:** Two festival bonus as per the company's rules and regulations are paid to each employee. Who has completed at least six months. Under six months getting as per ratio.
- **Casual Leave:** All employees are entitled to enjoy 10 days casual leave in a year with full salary /wages.
- **Sick Leave:** All staff & Workers are entitled to enjoy 14 days Sick leave full salary /wages.
- **Maternity Leave:** Female employees are entitled to enjoy 16 weeks (8 Weeks Prenatal & 8 weeks postnatal if she completes the 6-monthservice) maternity leave benefit prescribed by law.
- **Earn leave:** For adult worker 01 day leave for 18 days work, subject to the Completion of minimum 1 year service in the company
- **Festival leave:** Minimum 11 days as per law.
